### Current projects

1. Assessment of decks 801-813 have been completed. Board is waiting for a recommendation for repairs.
2. An addition roof replacement was done at #917 due to underlying roof issues. The Gazebo roof has also been replaced and Board Member Mike Hainline has added Solar Lights to jazz it up, Kudo's to Mike!!
3. Front Porch Railing Repairs, those railings that had been removed are now back in place.
4. Work has begun on Sidewalks that connect at the South corners and the North corners where there are currently no sidewalks at all. Also portions of sidewalk that were determined to be in very poor condition will be replaced at the same time as the new sidewalks.
5. Deck staining is still in process on the West side.
